



DONALD G. CICUZZA JR. **MEMORIAL SCHOLARSHIP** **ELIGIBILITY**

TO QUALIFY FOR THIS SCHOLARSHIP, YOU MUST BE A STUDENT IN THE JOHNSONBURG AREA HIGH SCHOOL AND PLAY AN ACTIVE ROLE IN YOUR SCHOOL AND COMMUNITY. THE STUDENT MUST BE PURSUING A POST-SECONDARY VOCATIONAL OR TECHNICAL CERTIFICATE OR DEGREE.

For consideration this application must be completed and returned to the guidance office by **March 1**. There will be no exceptions. The Scholarship Selection Committee, appointed by the Board of Directors of the Elk County Community Foundation, will select the scholarship recipients.

THE DONALD G. CICUZZA JR. MEMORIAL SCHOLARSHIP FUND

The Donald G. Cicuzza Jr. was a 1973 graduate of JAHS and within a year of joining the workforce he enlisted in the Army. A military career offered education and training to Don, first to become a mechanic to maintain and repair tanks then helicopters. Eventually education resulted in Don becoming an Army helicopter pilot, He retires as a Warrant Officer after 20 years of service but unfortunately passed away after 10 years of retirement. This scholarship is offered in his memory to honor his pursuit of education during his army career.

TERMS FOR SCHOLARSHIP

The committee will grant the **Donald G. Cicuzza Jr. Memorial Scholarship** as instructed. The selection of students to receive scholarship grants shall be made by the committee without regard to race, religion or sex of the applicant or their political perspectives. The committee will not place restrictions upon a candidate's choice of college or university.

The committee shall require, prior to the disbursement of any scholarship, proof that the scholarship recipient is actually enrolled as a student at the educational institution for which the grant is made, and all scholarship grants shall be paid only to the education institution attended by the recipient and never directly to the recipient. This grant covers tuition, fees, and books for the applicable fall, winter, or spring quarter. If you have questions, talk to your guidance counselor or contact the Foundation at 814-834-2125.

The Elk County Community Foundation is approved as a PATH Program participant.

If you are awarded a scholarship of at least \$200 from the Community Foundation, we will submit your name to AES/PHEAA for additional scholarship funding through PATH. To be eligible for the PATH award, you must meet the following criteria: be enrolled in an approved Pennsylvania College or career school; be a State Grant recipient and have a Federal Student Loan; and demonstrate financial need for PATH Program Grant. PATH grants will not exceed the Maximum State Grant for the particular academic year.
